Rand Fishkin along with Mike King may have published one of the biggest data leaks outside of the **Department of Justice** reveal around Google Search and its internal ranking features and signals. The document was from an anonymous source (no longer anonymous, see below) but verified by Rand Fishkin and contains a ton of details on how Google Search reportedly works.



Here are some of the things we have found particularly insightful:

- **Emphasis on Click Data:** Google is using click data more aggressively than previously thought is crucial. This highlights the importance of optimizing for user experience and ensuring that search results are relevant and engaging.
- **Freshness Matters:** The confirmation that freshness is a ranking factor is valuable. It reinforces the need for content updates and strategies to keep information current.
- **Contextual Understanding of Links:** The analysis of "full left context" and "full right context" around anchor text is fascinating. It shows that Google is going beyond simple keyword matching and trying to understand the true meaning and context of links.
- **URL History:** The possibility of Google storing up to 20 versions of a webpage is intriguing. This could explain why older versions of content sometimes appear in search results, even after updates have been made.
- **Topical Authority and Site Focus:** The emphasis on topical authority and site focus is a reminder that Google wants to see websites that are experts in their respective fields. This encourages creating high-quality, focused content that caters to a specific audience.
